

# Emeritus Status

Effective July 1, 2013

A Lawyer who has a) filed a Retirement Affidavit pursuant to Rule 2(C)(5) of the Rules of the Supreme Court on Lawyer Registration and b) elected restricted status under the CLE Rules may elect emeritus status by complying with the following requirements:

1. In the 90 days immediately prior to submission of the Emeritus Affidavit, the lawyer must take at least 5 hours of approved continuing legal education courses, including:
  - a. 3 hours of approved courses in the substantive area of law in which the lawyer intends to provide pro bono services;
  - b. 1 hour of approved ethics or professional responsibility; and
  - c. 1 hour of elimination of bias in the legal profession and in the practice of law.
2. The lawyer must submit a completed [Affidavit of Emeritus Status](#) to the Board office.
3. Once the lawyer's name appears on the Board's website, the Lawyer is authorized to provide pro bono legal representation consistent with [Rule 14](#).

Lawyers on Emeritus Status may only represent pro bono clients through an approved legal services provider. Please refer to [Rule 2B](#) for more information. Lawyers who wish to renew Emeritus Status must comply with [Rule 14F](#).
