

NEW Combined CLE and Lawyer Registration Portal: OASIS Launching late February 2023

The current CLE and Lawyer Registration portals will be combined into a single portal, known as OASIS, in late February 2023. Lawyers will be able to report continuing legal education credits and submit their annual registration statements in a single location.

What Can Lawyers Do in the New Portal?

- Report CLE attendance
- Submit CLE courses for accreditation
- Search for approved CLE courses
- Request CLE deadline extensions
- Transfer from Active CLE status to Restricted CLE status
- Submit your annual lawyer registration statement
- Update your fee status mid-cycle
- Request Certificates of Good Standing or duplicate licenses
- Update your Minnesota Trust account information and liability insurance
- Update your contact information, including name changes
- Pay any outstanding fees
- Download receipts

Frequently Asked Questions

1. When will the new site be live?

The current site is planned to go live on Monday, February 27, 2023. Both the current CLE and lawyer registration portals will be down starting at 4:00 p.m. on Wednesday, February 22, 2023 through Monday, February 27, 2023 while the new site is prepared.

2. How will I log into the new OASIS portal?

You will use your lawyer ID (the full 7 digits, so make sure to include leading 0s when logging in). The very first time you log in, you will need to click "Forgot your password?" and it will email you a password reset link.

3. I have different email addresses set up for the current OASIS (CLE) site and the Minnesota Attorney Registration System (MARS) portal. Which email address will be used in the new OASIS portal?

Whichever email address you have in the Minnesota Attorney Registration System is the email address that will transfer to the new OASIS portal. You can

update your email address prior to February 10, 2023 in order to get it to transfer to the new portal correctly: <https://onlineregistration.courts.state.mn.us/>

4. What should I do if I don't have an email address on file, or if my email recently changed and needs to be updated?

If you do not have an email address on file, email lawyerregistration@mbcle.state.mn.us with your name, lawyer ID, and email address that you would like added to your file. If your email has recently changed and needs to be updated, you can either log in to the current [Minnesota Attorney Registration System](#) and make the update by February 10, 2023, or contact lawyerregistration@mbcle.state.mn.us if you are unable to log in.

5. I only use the current OASIS portal to report my CLE credits, and I don't want to pay my annual registration statements online. Can I keep them separate?

You can continue using new OASIS to only report CLE credits. If you are currently receiving paper registration statements, you will continue to receive paper registration statements from the new system. If at any time you want to try paying your registration statement through the new system, you are welcome to do so once you receive your registration reminder.

6. Will the CLE Sponsor Portal change?

No, the Sponsor Portal will remain the same. However, it may be down during the same time frame as the Attorney Portal in order to launch the new OASIS.
